Dear Mr. Goodin:

On behalf of Delta Waste Landfill (Delta Waste), Golder Associates Inc. (Golder) is submitting this Permit Modification (PM) to the existing Texas Commission on Environmental Quality (TCEQ) Permit Number Municipal Solid Waste (MSW) 2344, located in Harris County, Texas. The proposed PM discussed in this letter is summarized in the following table:

This requested PM does not increase the volume of waste that can be placed at the site.

1.0 BACKGROUND INFORMATION

The Delta Waste Landfill is located in southern Houston on the south side of Beltway 8, west of FM 521, and east of the Hiram Clarke Road in Harris County, Texas.

The maximum waste acceptance rate as identified in the Permit Application is estimated to 1,287,000 cubic yards per year or 4,500 cubic yards per day.

2.0 REQUESTED PERMIT MODIFICATION

The proposed PM requests changes to the Site Operating Plan to reflect the increase in the waste acceptance in excess of ranges identified in the existing TCEQ approved SOP. Based on site operating conditions, the only changes required by this increased waste acceptance rate are the equipment required for the site operations.

The related text and tables in the SOP have been revised to identify the equipment required to manage the increased estimated annual acceptance rate. Redline-strikeout versions of the revised pages are included in Appendix A of this letter. Clean versions of the revised pages for inclusion into the Permit Amendment are included in Appendix B of this letter. The parts of the SOP modified by this PM include:

- Cover page
- Text pp. IV-3, and IV-13
- Table 4-1, pg. IV-14

3.0 MODIFICATION TYPE

This PM is specifically identified as a required modification in 30 TAC §330.125(h).

Since this change is not listed in 30 TAC §305.70(j) and (k) this PM is being submitted as a PM in accordance with 30 TAC §305.70(l). As identified in 30 TAC §330.125(h) notice in accordance with 30 TAC §305.70(k) is required for this PM. This notice will be mailed after TCEQ approval of this PM.

Additionally, in accordance with 30 TAC §305.70(d), this PM is a minor change to a MSW facility and its operation that does not substantially alter the permit conditions and does not reduce the capability of the facility to protect human health and the environment.

4.0 PERMIT/REGISTRATION MODIFICATION AND TEMPORARY APPLICATION FORM AND SIGNATURE PAGE

The Permit/Registration Modification and Temporary Authorization Application Form including a Signature Page is included in Enclosure 3 to this letter.

5.0 NOTIFICATION

Property owner information was obtained from Harris County Appraisal District (HCAD) records. Based on review of HCAD records, in accordance with 30 TAC §330.59(c)(3)(B), there are no mineral interests identified for the Delta Waste Services property.

2.6 Alternative Schedules (§330.113(9))

The executive director, in accordance with §330.113(g), may set alternative schedules for recordkeeping and notification requirements as specified in §330.113(a-f), except for notification requirements contained in §§330.300-330.305 for any proposed lateral expansion located within a five-mile radius of any airport runway end used by turbojet or piston-type aircraft or notification relating to landowners whose property overlies any part of the plume of contamination if contaminants have migrated off site as indicated by ground water sampling.

2.7 Annual Waste Acceptance Rate (§330.113(h))

As listed in Table 2-1, the Delta Waste Landfill will maintain as part of the operating record, documentation of the annual waste acceptance rate for the facility in accordance with §330.113(h). Records will include maintaining the quarterly solid waste summary reports and the annual solid waste summary report as required by §330.603. The annual waste acceptance rate, as established by the sum of the previous four quarterly summary reports, will be evaluated by the Delta Waste Landfill to determine if the waste acceptance rate exceeds the rate estimated in the approved permit and SOP. Should an increase in waste acceptance be established, the facility will determine if the increase is due to a temporary occurrence. Should the waste acceptance rate exceed that established in the approved permit, and that increase is not due to a temporary occurrence, a permit modification would be prepared within 90 days of the exceedances as established by the sum of the previous four quarterly summary reports in accordance with then applicable TCEQ regulations to propose changes, if required, to manage the increased waste acceptance rate.

The Delta Waste Landfill anticipates that the waste acceptance rate for the facility will increase during the site life. This facility is permitted for an initial waste acceptance rate of 500,500 cubic yards per year, increasing to an estimated ~~1,287,000~~ 2,145,000 cubic yards per year. Refer to Part III, Site Development Plan Narrative, Section 6 -Site Life Projection, and Appendix IIIA -Site Life Calculations for the site life calculations and assumptions related to estimated waste compaction and weekly cover volume. This SOP includes provisions for site management and site operating personnel to the general and site-specific requirements for the waste acceptance rates established in the permit.

4 EQUIPMENT

30 TAC §330.114(2)

Sufficient equipment will be provided to conduct site operations in accordance with the landfill design and permit conditions.

The following list of equipment is expected to be routinely available for use at the facility. Equipment requirements may vary in accordance with the method of landfill operations or the waste acceptance rate at any given time. Additional equipment will be provided as required for increasing volumes of incoming solid waste. Other equivalent types of equipment by other manufacturers may be substituted on an as-needed basis. The minimum number of pieces of equipment to be provided for daily operations is listed in Table 4-1 on page IV-14.

The estimated waste acceptance rate for the Delta Waste Landfill is described in Part III, Appendix IIIA - Site Life Calculations, and in Section 2.7 of this SOP. As defined, the initial waste acceptance rate is estimated to be 500,500 cubic yards per year, or 1,750 cubic yards per day. The maximum waste acceptance rate is estimated to be ~~1,287,000~~ 2,145,000 cubic yards per year or ~~4,500~~ 7,500 cubic yards per day. The size, number, types, and equipment manufacturers will vary during site operations based on operational practices and on the annual waste acceptance rate.

Compactors are typically used for spreading and compacting the refuse and also for compacting the cover material. Dozers are typically used for soil movement and placement and for emergency waste compaction. Scrapers or excavators and haul trucks are typically used for excavating both the cover material used in site operations and the future disposal areas. The landfill will use either scrapers or an excavator and haul trucks for soil excavation and movement. The motor grader is typically used for road maintenance, ditching, surface water control, and final grading of the completed fill areas. The water truck will be used for dust control and moisture conditioning of soil materials, as necessary. A farm tractor and pickup truck(s) will be used as needed for miscellaneous maintenance, litter control and personnel use. Backup equipment will be provided from contractors or local rental companies to obtain equipment in the event of a breakdown or maintenance event to avoid interruption of waste services.

The site will be equipped with fire extinguishers of the type, size, location, and number as recommended by the local fire department. Each fire extinguisher will be fully-charged and ready for use at all times. Each extinguisher will be inspected on an annual basis and recharged, as necessary. These inspections will be performed by a qualified service company, and all extinguishers will display a current inspection tag. Inspection and recharging will be performed following each use. At a minimum, the gatehouse, equipment and maintenance area, and all landfill equipment and vehicles will be equipped with fire extinguishers.

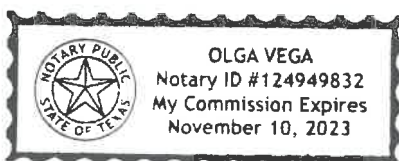
